ILCHF was created in December 2002 through an action of then Attorney General Jim Ryan and an Illinois insurance carrier.

This action and a settlement of approximately **\$125 million** established Illinois' only private foundation focused solely on the health needs of children across the state.

Every Child in Illinois Grows Up Healthy.




EDI ACTION PLAN PURPOSE & DOMAINS

ILCHF GRANTMAKING

ILCHF allocates approximately \$5 million per year toward children's mental health, children's oral health, and unmet/emerging needs.



Overview

ILCHF is celebrating 20 years of partnering with organizations across the state of Illinois committed to improving the health and well-being of children and families. To commemorate this remarkable milestone, ILCHF is issuing **"SUPPORTING A STRONG CHILDREN'S HEALTH WORKFORCE IN ILLINOIS" grant opportunity which** aims to award 21 grants of \$20,000 each (for a total investment of \$420,000) to fund projects across the state of Illinois that inspire young people to join the children's behavioral and oral healthcare workforce.

General RFP Overview

The goal of the project is to inspire the next generation of healthcare leaders.

- This grant opportunity is available to nonprofit organizations that have the capacity to help children learn more about health care careers.
- These are one time grant funds that can be used to seed new programs or expand existing ones.
- Preference may be given to organizations serving historically underrepresented youth populations and/or professional healthcare workforce shortage areas.





Equity, Diversity, and Inclusion

- ILCHF values board, management and staff diversity among its grantees that is reflective of and/or responsive to the people our grantees serve.
- The Foundation recognizes that diversity is expressed in different ways, including race, gender, religion, ability, economic status, sexual orientation, language, national origin and age.
- Collecting EDI data will create a deeper understanding of how diversity is integrated across various organizations.
- This information will inform but not be determinative of an application's success.
